- 1. Call Order Regular Meeting: President, Jason Olson called to order at 6:01 p.m.
- 2. Comments: none
- Discussion to Approve and Action to approve the Minutes of the January 9, 2017 Special Meeting. Upon motion by Jason Olson and a second by Bradley Elliott, the members <u>voted</u> <u>unanimously</u> to approve the meeting minutes.
- 4. **Discussion and Action to Approve** Ground Lease Purchase Agreement For Area 1, 2, and Pad Site C Located In The Town Of Little Elm, Denton County, Texas. Upon a motion by Bradley Elliott and a second by Robert Anderson, the members **voted unanimously** to authorize the EDC President, Casey Russell, to execute the Ground Lease Purchase Agreement as presented.
- 5. **Discussion and Action to Approve** Ground Lease Purchase Agreement For Pad Site A Located In The Town Of Little Elm, Denton County, Texas. Upon a motion by Bradley Elliott and a second by Jason Olson, the members <u>voted unanimously</u> to authorize the EDC President, Casey Russell, to execute the Ground Lease Purchase Agreement for Agenda Item 5 with a revision to Section 1.6 to add language to the "Commencement Date" means the date of receipt of a certificate of occupancy for a minimum of 4,000 square feet

of retail/office/restaurant space located on the Land, or four (4) years from the Effective Date of this Agreement, whichever is sooner.

- 6. Discussion and Action to Approve Ground Lease Purchase Agreement For Pad Site B Located In The Town Of Little Elm, Denton County, Texas. Upon a motion by Robert Anderson and a second by Will Gentry, the members voted unanimously to authorize the EDC President, Casey Russell, to execute the Ground Lease Purchase Agreement for Agenda Item 6 with a revision to Section 1.6 to add language to the "Commencement Date" means the date of receipt of a certificate of occupancy for a minimum of 4,000 square feet of retail/office/restaurant space located on the Land, or four (4) years from the Effective Date of this Agreement, whichever is sooner.
- 7. **Discussion and Action to Approve** Ground Lease Agreement For Area 3 Located In The Town Of Little Elm, Denton County, Texas. **No Action Taken**.
- 8. **Discussion and Action to Approve** Ground Lease Purchase Agreement For Area 4 Located In The Town Of Little Elm, Denton County, Texas. Upon a motion by Will Gentry and a second by Bradley Elliott, the members <u>voted unanimously</u> to authorize the EDC President, Casey Russell, to execute the Ground Lease Purchase Agreement for Agenda Item 8 with a revision to Section 1.6 to add language to the "Commencement Date" means the date of receipt of a certificate of occupancy for a hotel as approved by the Landlord and located on the Land, or five (5) years from the Effective Date of this Agreement, whichever is sooner.
- 9. **Discussion and Action to Approve** Ground Lease Purchase Agreement For Area 5 Located In The Town Of Little Elm, Denton County, Texas. Upon a motion by Michael McClellan and a second by Robert Anderson, the members <u>voted unanimously</u> to authorize the EDC President, Casey Russell, to execute the Ground Lease Purchase Agreement for Agenda Item 9 with a revision to Section 1.6 to add language to the "Commencement Date" means the date of receipt of a certificate of occupancy for a minimum of 10,000 square feet of commercial/entertainment space located on the Land, or five (5) years from the Effective Date of this Agreement, whichever is sooner.
