- 1. Call Order Regular Meeting at 6:34 p.m.
- 2. **Presentations and Announcements:** Joe Shipman w/ Luminous took photos for EDC website.
- 3. Financial reports for Principal Management Group presented by Ginnye Nance.
 - (A) Upon motion by Marc Matney and second by Micheal Blazer the members voted 4-0 to reduce the lease amount for Praise Fellowship Worship Center located at 111 Eldorado Parkway to \$3600.00 per month, and to extend said lease to December 31, 2012 as well as the other two EDC lease properties at their existing lease amount and extend their leases to December 31, 2012. The EDC will no longer assume any financial obligations for repairs and/or maintenance for the Praise Fellowship Worship Center. Praise Fellowship Worship Center is also required to show proof of insurance on the structure within 15 days, to prevent being in default of their lease. Curtis Cornelious abstained from voting.
 - (B) The Board directed Ginnye Nance w/ Principal Management Group to move forward with having the property at 129 Main Street cleaned out and to take inventory at said location.
